ORS 94.774 is an incorrect referral to this law. The applicable law is ORS 65.774.

- 1. All parking violation letters dated from January 18, 2014 to present may be released by CMI in hard copy form to Mr. Leflar with all homeowner identities redacted.
- 2. The names of homeowners filing complaints will not be released.
- 3. All e-mail correspondence regarding Mr. Leflar has been sent to him, as he was copied on the request sent to CMI to mail the letter of violation to him. Therefore he already has this information. No other references to Mr. Leflar have been made in any form.

There will be not a release of e-mail correspondence, as there have never been any racial or homophobic slurs made regarding anyone in our community by any Board member. There has never been any reference to any homeowner regarding ethnicity or any reference to LBGT.

Discussion regarding Mr. Leflar's violation of the fire code; Mr. Lefler violated the fire code twice before the letter was sent. Mr. Leflar confirmed he was parked across the alley blocking all fire access with 2 vehicles.

There have been a total of 4 letters sent to homeowners in the period between January 18, 2014 to date, and 1 other earlier in January, 2014. In most cases the parking resolution was placed on windshields before a letter was requested to be sent by CMI. In addition, there were 7 other violation notices posted on vehicles. There will be no further notices placed on vehicles, instead letters will be sent by CMI to the offender directly.

IV. Motion to adjourn was seconded and passed at 10:35AM.
