#### From the Treasurer

The Budget: Every year a group of owners meet in the Fall to prepare a plan on how Millridge, H.O.A., a not-for-profit corporation, will spend the revenue paid by the owners in the form of dues. Guidance in preparing this plan, the Budget, comes from several sources. One is reviewing how money is being spent that current year. A second is reviewing past year expenditures of that year's budget. A third source is from C.M.I. concerning accounts as utilities, the increases they plan to apply that year. A forth source are requests from leaders of departments concerning increasing their budget to account for new projects.
