# **Proof of Insurance**

Pursuant to the Bylaws of Millridge Townhouses, all homeowners are required to provide proof of personal homeowners' insurance.

**8.1 (c)**: "Each Owner shall be responsible for obtaining, at his own expense, insurance covering his property not insured under paragraph (a) (Property insurance covering loss or damage from occurrences including, but not limited to, fire, vandalism, and malicious mischief with extended coverage endorsement; and such other coverages such as flooding), and against his liability not covered under paragraph (b) (A policy or policies insuring the Association, the Board of Directors, Owners, and managing agent against liability to the public or to the Owners and of Common Area and their invitees or tenants incident to the Lot ownership or use of the property), unless the Association agrees otherwise."
