
A big thank you to Dave Edwards, Sue Seaver, and Robert and Brady Richardson for removing debris from the downed trees due to the wind storm.

A Few Reminders:

Reminder: Owners are responsible for maintenance and repairs to the foundation and crawlspace of their unit.

Tip: Regularly clearing the debris from the trap at the bottom of the downspout will prevent it from overflowing and accumulating along the foundation, which could run into your crawlspace and lead to mold and other problems.
