RECYCLING TIPS PRESENTATION

A specialist from Washington County came here to offer "Recycling 101" at the start of the February 22nd board meeting.

Homeowners were offered the following tips for recycling:

- No lightbulbs or flat glass panes only glass bottles and jars belong in glass recycle bins.
- No No No No plastic bags!
- Plastics ONLY include bottles, buckets, and tubs – do NOT put in plastic clam shell containers from restaurants, berry containers, or plastic cups.
- No plastic lids (even if the container they belong to is recyclable).
- Take caps off with all recycling.
- Do not put in boxes that had contained frozen foods, paper with mixed materials, Kleenex, or paper towels.
- Coated cardboard soup and milk cartons okay IF rinsed.
- DO NOT put shredded paper (or any recyclables) in plastic bags use paper bags to contain recyclables.

HOA INSURANCE INFORMATION

was presented on Thursday, February 8th at 6:00 **PM in the clubhouse. Larry Thompson,** of the Larry Thompson Agency, Inc. presented on how our HOA American Family Insurance works with individual homeowners' policies and further explained the coverage and limitations of our Millridge HOA policy. As was discussed at the meeting, many homeowners found that they were possibly under or over covered by their own homeowner's policy. It's common for townhouse owners to be either over-insured or under-insured through their own homeowners' policies because of the coverage and deductible associated with the HOA's property insurance.
